Business Scenario Description: Usage of Report BPM01. 2. Issue Description: Due to a not activated condition the report shows time periods without alerts which should be hidden according to specification. 3. No Workaround available in DWH. 4. TARGET Services concerned: T2S-DWH. 5. Effects and restrictions on concerned TARGET Service: No functional impact. Layout issue. 6. Required SW change: Activation of the generell condition so that time periods without alerts are hidden. 7. DWH report: BPM01)
